A. SPECIAL CALLED MEETING – Chair Exum called meeting to order.

Mr. Maxwell made a motion to amend agenda to move item #3 Request to Create IT Position; to #1, Mr. Cody seconded. Vote was unanimous.

1. Request to Create IT Position - Administrator requested to create an IT Position within the Administration Office; to offset fees being spent with SGRC; and save County money. - **3.** Appeal Request Ken Collins County Attorney asked Mr. Collins if he was appearing for a grievance or to appeal the Board's decision of termination. Mr. Collins stated he wanted to appeal the decision of the Board. Therefore; the appeal was held in open session and not executive session. The Board allowed Mr. Collins to present his appeal.

Mr. Collins stated it's his desire to seek reappointment as the County's Elections Supervisor. He stated the allegations were without merit since the allegations suggested he violated a State law.
