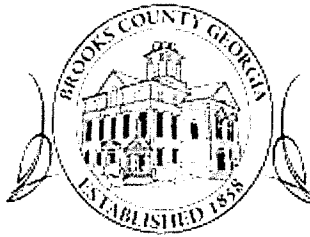

Meeting Minutes

October 11, 2023

I. Call to Order

Mr. Bentley called to order the regular meeting of the Brooks County Board of Tax Assessors at 5:15 p.m. on October 11, 2023 with all members present. Also in attendance were Wayne Waldron, Chief Appraiser and Mica Jarvis, Secretary. Mr. DeShazor led the Board in prayer.

II. Approval of Minutes from Previous Meetings

- 1) Assessors reviewed minutes from the regularly scheduled meeting held on September 13, 2023. After review, Mr. Manning made a motion to approve the minutes with corrections. Mr. DeShazor seconded. All members in favor. Motion carried.

III. Approval of Proposed Agenda

Assessors reviewed the proposed agenda for the current meeting. After review, Mr. Manning made a motion to approve the proposed agenda as printed. Mr. DeShazor seconded. All members in favor. Motion carried.

IV. Appearances/Taxpayer Requests

- 2) Mr. A.P. McCord came before the Board requesting a reduction in taxes for his mother's home which burned on January 4, 2023. Mr. Waldron presented Mr. McCord and the Board with the applicable Rules and Regulations from the Department of Revenue which clearly states that the date of valuation is January 1 of every year and the local board is prohibited from enacting procedures that are contrary to Georgia law. The Board expressed their sympathies and understanding for Mr. McCord's situation and after discussion informed Mr. McCord that there would be no way to adjust the value of his mother's home for the 2023 tax year.
- 3) Mr. Waldron informed the Board that a parcel in the ownership of Crossroad Community Center (map/parcel 036 0010) was changed from exempt to taxable due to an apparent lack of qualifying exempt use. Members of the Community Center have since provided meeting minutes and other documentation that demonstrates the owners are actively engaged in the process of the restoration of the historical building

which is considered a charitable use. After review, Mr. DeShazor made a motion to reinstate the property's exempt status for tax year 2023. Mr. Manning seconded. All members in favor. Motion carried.

V. Unfinished Business

- 4) Mr. Waldron informed the Board that the Board of Commissioners has re-appointed Mr. Manning to another term on the Board of Assessors. Mr. Manning's next term will be for three years beginning January 1, 2024.
- 5) Assessors reviewed covenant breach, releases, and application requests (see attached). After review, all requests were approved as attached. The breach of the 2016 Conservation Use covenant on parcel 017 0002 was a result of medically demonstrable illness as evidenced by the documentation provided. The new FLPA covenant on parcel 050 0005 and related releases are a product of an ongoing appeal and the owner electing to convert from Conservation Use to Forest Land Protection for 2023 to consolidate all parcels and resolve the appeal.
- 6) Assessors reviewed a listing of property owners who were mailed 30-Day Intent to Terminate letters on September 18, 2023. Those covenants will be released, and the estates or new owners will have the ability to apply for new covenants beginning January 1, 2024.

VI. New Business

- 7) Assessors reviewed a list of property owners with Standard Elderly School Tax Homestead Exemptions (S3) who have reached the age of 65 in 2023 and now qualify for the larger Standard Elderly General Homestead Exemption (S4) (see attached). After review, the Assessors approved the increase in exemptions as attached.
- 8) Assessors reviewed parcel combination requests (see attached). After review, parcel combinations were approved as attached.
- 9) Assessors reviewed Appeals>Returns/Errors/Adjustments (see attached). After review, adjustments were approved as attached.
- 10) Assessors reviewed a list of properties that have covenants expiring on December 31, 2023. The list consists of 92 FLPA covenants and 355 conservation use covenants. Mr. Waldron informed the Board that expiration letters will be mailed by October 31, 2023 as required by law.

VII. Chief Appraiser's Report/Comments

- 11) Mr. Waldron informed the Board that he has reached out to the County Administrator regarding the status of the new flooring for the office and was told to contact Scott Hockenberry to see when they can get started.

Mr. Waldron and Ms. Jarvis attended the WinGAP conference and 20-hour course on Residential Schedule Building in Savannah last week. At the conference, they were able to meet with the representatives from Data Cloud Solutions and GMASS.

The Mobile Assessor contract is still in process and will be provided to the Board as soon as it is available. Mr. Waldron has not heard back from VC3 regarding the need to update to a newer version of SQL Server and the office has yet to experience any issues with the older version. The first quarter of the current fiscal year is now complete, there have not been any unexpected expenditures to date. The monthly budget reports have been requested but the accounting department was unable to provide them.

All accounts have been turned over to the Appeal Administrator to schedule the Board of Equalization hearings.


