JOB SUMMARY

Performs general inspection work in securing compliance with the municipal building control program, zoning code, and related regulations. Work involves approving applications for building and the moving of existing structures; inspection of overgrown properties, abandoned vehicles, trash and debris; building and other structures for structural safety, zoning compliance and ordinance and code violations; and handling complaints from citizens. Work is performed under the direction of the Board of Commissioners and the County Administrator.

ESSENTIAL JOB FUNCTIONS

- Inspects old and dangerous structures which may be subject to condemnation, especially for structural, safety and other hazards; condemns structures which jeopardize public health, safety, and welfare, checks complaints on junked cars and other refuse left on the County streets and properties.
- Issues subpoenas and testifies in municipal court concerning violations of building codes, zoning ordinances, and other regulatory codes.
- Interprets and explains building and zoning ordinances, codes, and regulation to builders, contractors, homeowners, and other interested parties.
- Inspects buildings being wrecked to ensure that proper safety methods are being followed and to protect adjacent property and the public.
- Prepares reports and keeps records regarding zoning/code enforcement.
- Responds to complaints from the public.
- Performs related work as required.
- Performs other related job duties as assigned.
